### SBC Core Release 5.1.x End of Product Sale Notification for US Federal Government Agencies and Customers

Ribbon Communications, Inc. (“Ribbon”) is announcing the End of Product Sale (EoPS) and End of Support (EoS) dates for SBC Core release 5.1.x software running on the Ribbon SBC 5110, SBC 5210, SBC 5400, SBC 7000 and SBC SWe products. US federal government agencies and customers with active maintenance agreements are recommended to upgrade to SBC Core release 6.2.3 software for continued support.

Note - Ribbon announced End of Product Sale (EoPS) SBC Core release 5.1.x in Dec 2018. This announcement extends the same EoPS notification to US federal government agencies and customers.
